Overhead Crane Pendant Remote

Course Overview

To provide the theoretical and practical knowledge to safely operate an overhead crane with pendant or remote-control operating system.

Delegates who are required to safely operate an Overhead Crane within the scope of any working activity they are employed to carry out.

- Management of Health and Safety at Work Regulations (MHSWR)
- The Health and Safety (Safety Signs and Signals) Regulations & Code of practice for safe use of cranes, inspection, testing and examination 7121
- Component Parts and Pre-use checks
- Basic training (including basic slinging)
- Statutory requirements
